TO UNDERSTAND WHAT IS ROCKING FAMILIES

People meet, they form couples, children are born. Couples become parents and an increasing number of them fall out of love, come apart, split up, and may form a new family. Ideally, the transition from being a conjugal couple to being a parental couple should occur in the best interests of the child, who has "the right to maintain on a regular basis a personal relationship and direct contact with both his or her parents, unless that is contrary to his or her interests" (Charter of Fundamental Rights of the European Union, Art. 24 – 8 December 2000)

Since the end of the 19th century, the stance of judicial public authorities on children rights has become increasingly protective. At first, to control and to punish the excesses of paternal power (child exploitation), and now to protect the interests of the child as a subject of rights, namely when the parents cannot come to an amicable separation.

This interference of the public sphere in the couples' private life had to go hand in hand with a rigorous, objective and structured regulation – the 18 July 2006 Belgian reform law on equal shared parenting – lest the legal system lose its attributes and its function by diving deeply into the individual passions.

With this reform, the legislators stated that it should be in the best interests of the child to live with both his or her parents, and entrusted the fulfilment of this right to the Family Court, which has given judges a lifeline when dealing with family disputes. Nowadays, the shared physical custody affects, through different districts, 35-60% of children from broken homes where at least one of the parents has asked for this arrangement. Time allocations vary from 50/50 to a 5 to 9 days ratio.

After several years of observing and studying equal shared parenting to understand the extent of its influence, the Ligue Bruxelloise Francophone pour la Santé Mentale (Brussels Frenchspeaking League for Mental Health) and the magazine Filiatio have organised this symposium as a place to meet up, share information, be trained, study and practice. All this, for an audience of scientists, child psychiatrists and psychologists, judges and lawyers who are called into the intimacy and the solitude of their consciences where the idea of Justice comes into force for the best interests of all the beaming

EQUAL SHARED PHYSICAL CUSTODY

AND SCIENTIFIC RESEARCH

For several decades, a number of researchers in various domains have been looking into the different protagonists, realities, hypotheses, results and possible negative consequences of shared parenting, far from disputes and unconcerned by the need to make a statement.

This previously unexplored scientific field stands out for the diversity of its investigation techniques, objectives, tools and samples, ... In order to make full use of all of these sources and draw pertinent and valid conclusions, these scientists have been conducting meta-analyses on existing papers, looking to make relevant comparisons between different research works, thus drawing a solid and reliable basis for academic consensus. Works by Dr. Edward Kruk and Jani Turunen are an authority in the field of parenting plans, especially concerning shared physical custody. In Belgium, too, teams of researchers are working towards a better understanding of family policies. Some of these teams have been involved in longitudinal studies since 2008, others are to lead research programs for the next five years.

13:30 EXPERT PSYCHOLOGICAL ASSESSMENT AND PSYCHOLOGICAL SUPPORT: WHAT TO EXPECT?

The rulings which the Ligue Bruxelloise Francophone pour la Santé Mentale has accessed so far show a legal system which, not having a large clinical and academic debate to refer to, often looks for answers into unreliable documentation and clinical trials which are, indeed, authentic, but not thorough enough. And yet, certainties of yesterday on childhood, on stress factors such as the parenting conflict, and on the child's "free" speech, are evolving with the realities of "new" families and scientific research. It is important that these changes and the debate they are liable to promote are tackled and taken into account in order to provide magistrates with more topical points of reference.

15:30 A LEGAL PERSPECTIVE ON THE IMPLEMENTATION OF CO-PARENTING

Foraed in the fire of the États aénéraux des Familles (national conference on family policies), the 18 July 2006 law in favour of equal shared physical custody is profoundly democratic. It is also deliberately educational, as it states which aim to pursue foremost, posing as the sole condition for the judge who decides differently to justify his/her decision. Ten years later, the ambition for legal predictability is still unfulfilled. According to some, the ground truth tells a different story, and this law seems to poorly reflect the real experiences of the families. Moreover, some authors call to mind the need to provide a justification in case of a decision in favour of shared physical custody. As for the justifications given for decisions against this arrangement, they are mostly testament to the judges' (and the lawyers') difficulties in considering separately the conflictual situation linked to the dissolution of the conjugal couple and the need for the parental couple to survive in order to protect the interests of the child. Are the ongoing evolution towards a Justice of mediation and conciliation, and the propositions to adopt into the Belgian law the Dutch parenting plan the answer to the judge's solitude, to the hardship of too many parents and to the child's interest?

17:00 CONTEMPORARY EVOLUTION OF FAMILIES AND PARENTING, AND THE BEST INTERESTS OF THE CHILD

"During the second half of the 20th century, family has taken different forms, progressively creating a "mosaic" of different situations: children who are separated from their parents, children from broken homes, adopted children, children living in differently structured families (single parent families, same-sex parent families, blended families, etc.), children conceived through assisted reproductive technologies and children in search of their own origins," write Professors Jacques Marguet and Laura Merla in the introduction to their report "L'intérêt supérieur de l'enfant dans la mosaïque familiale [...]" ("The best interests of the child in diverse, new families [...]" - Marguet & Merla, 2016). The gim is to ponder the conditions that would assure the best interests of the child in these "new" families, while trying to answer a question which is, after all, as simple as it is pertinent: the best interests of the child on behalf of which the State is entitled to intervene in the privacy of the families - does it still match the children's own idea of their interests?


